Investment & Lock-In Period – SEP / ESP



Investment

- Minimum investment of ₹ 1,00,000.00 (One Lakh)
- Succeeding investment in Tranches of minimum size of INR 25,000.00 (Twenty-Five Thousand)
- Maximum Investment of ₹ 2,00,000.00 (Two Lakh)

Lock-In Period

- 6 Months
- Lock-In Period extends by 6 Months upon every Successive investment by the Licensee.
- Partial dilution of Investment between Minimum Investment (1 Lakh to Maximum Investment 2 Lakh is possible after the Lock-in-Period.

Marketing – Leads – SEP / ESP

- Licensee Operated Model
 - Leads required for the Licensee or for his / her team will be charged extra.
 - Licensee can ask for additional leads by investing additional marketing budget for their center. Separate Invoice will be generated in the name of the SEP / ESP Licensee Holder.
 - Additional marketing investment for Licensee Operated model will not be considered as the increase in the Capital of the Center.
 - Pre-Verified Leads will be provided to the Licensee Operated Unit.
 - Licensee is also encouraged to bring in additional Leads from his / her / their contacts
- Company Operated Model
 - 25% of the Investment made by the SEP / ESP Licensee holder will be used for Generating Leads for the Business for 6 Months.








Operations - SEP / ESP

- ESP Center is eligible to be operated in both the Models
 - Licensee Operated Unit
 - If a Sale is achieved due to 100% Contribution from the ESP License Holder, he / she will be entitled for 100% of additional Fee / Commission as under:

IBA - 8%
IBC – 8%
SEP / ESP – 4%
Micro Franchisee – 4%
Franchisee – 4%

- **No restriction** in the revenue available to Withdraw by the Licensee in the Licensee Operated Model.
- Licensee can withdraw commissions on a **monthly** basis from the Profits / commission available in the Licensee Operated Unit.



Operations – SEP / ESP

- Company Operated Unit
 - Quarterly Payouts
 - Auto Model (1/3rd of the Profit of the Center) Only
 - Maximum Profit for the center through the Company Operated
 Model per Quarter is limited to 25% of the capital. Any excess
 profits generated in the quarter will get carried forward to the next
 quarter.
 - If the center has Profits getting carried forward to the next quarter for 3 successive Quarters then the center is eligible to be upgraded to the Micro Franchisee Model.
 - If Cumulative Profits getting carried forward crosses ₹2 Lakh in any Quarter then with that excess Profit, a Micro Franchisee center is activated Automatically.
 - An Individual can hold multiple licenses simultaneously.

Operations – SEP / ESP


- ESP License holders will get
 - Email ID & Visiting Card
 - Access to Lead Management & Project Management Platform
 - Unlimited number of Individual users can be added under ESP license. One Time fee of INR 1,000.00 + GST Per User as a Set up Fee will be charged to the ESP License Holder.
- All Bank procedures will be managed by CMPTL
- All Payment requests made by the ESP License Holder will be processed if there is availability of Drawable Funds under the ESP License Holder Account within 7 (Seven) Business Days.
 - Drawable Funds = Total Available Funds in the account less Funds reserved for Operational Expenses of the Center.

- Operational Support
 - Executive 1-2 Years of Experience in the domain

 - Sr. Consultants 15-30 years experience



Benefits – SEP / ESP

- Ease of Starting the Business
 - Guaranteed Returns of 6% on the Capital per Quarter or 24% per Annum or the Profits of the Center which ever is higher.
 - Profits settled Every Quarter.
 - Make your money work for You (CO Auto) as well as gain 100% of commissions on conversions due to your effort (Licensee Operated).
 - Individual Operated and Company Operated. You can Continue your Job while your earning and revenue gets Established.
 - No Conflict of Employment as you will only be the License Holder in the Company Operated Model and not working as an Employee or Director of a Company.
 - No need to register a Company
 - No entanglement with the Accounting Aspects.
 - Easy to Start.. Easy to Switch.. Easy to Exit.
 - Start with Smaller Investment and grow your revenue and business.



Limitations of SEP / ESP Model

- Maximum Investment is restricted to 2 Lakh beyond that upgrade has to happen for Micro Franchisee or Franchisee Program.
- Only 2 (Two) Work Spaces are made available in the Platform
 - One Individual / Licensee Operated Section Leads for the Individual section will cost extra.
 - One Company Operated Section
 - Additional Work Spaces are available in Micro Franchisee and Franchisee Models only.
- Company Operated
 - Auto Model Available
 - Cruise Model Not Available.
- Recurring Business Revenue is not applicable but is available in the Franchisee Model.
- People who want to have their own Company and grow their business can do that in the Franchisee model but it is not possible in the ESP
- Dedicated Employees is not available in **ESP**
- Establishing Business Partners is not available in ESP.





Exit from the SEP / ESP

- If the License Holder wants to cancel their License after the Lock-in Period, he / she can send a request for cancellation with a 30 day notice period. The request will be processed in T+45 days from the date of such notice.
- A Processing Fee of 10% of the Withdrawal amount will be levied at the time of Exit from this ESP and the balance amount credited to the Exiting ESP License Holder. The Processing Fee is Waived off if the ESP Holder is upgrading funds to start an Independent CMPTL Franchisee or a Micro Franchisee.
- If an ESP Licensee is upgrading to a Micro Franchisee or an Independent Franchisee, he / she will have to pay the differential fee of Franchisee Fee less the profits and capital available in their center. An Examples is as shown below.
 - If the Invested Amount = ₹1 Lakh
 - Accumulated Profits = ₹0.75 Lakh
 - Total = ₹1.75 Lakh
 - If the Licensee want to upgrade to a Micro Franchisee by adding another ₹25K, then the user will get a MF with a total invested amount of ₹2 Lakh (1.75L + 0.25L).



License Validity – SEP / ESP

- SEP / ESP License is Valid for 5 (Five) Years.
- License can be renewed after 5 Years after submitting the KYC Documents
- License Renewal Charges of ₹10,000/= plus GST will be charged for renewal process.
- To maintain the validity of the SEP / ESP License for 5 Years, it is mandatory for the Licensee to maintain a Minimum License Fee of ₹1,00,000/= with CMPTL.
- If the License Holder cancels the License during the period of 5
 Years and withdraws complete funds from the system, then the
 validity of License will expire after the Grace Period. A grace period
 of 30 (Thirty) Calendar days is extended for the License Holder to
 re-activate the License. If no amount is reinvested, then all the
 clients and assets of the respective Licensee in the system will be
 merged with the other assets of CMPTL and Licensee will loose full
 rights on those assets.



Transfer of Client Accounts – SEP / ESP




- ESP License Holder Exits CMPTL Network No Client will be Transferred. Clients are at their Liberty to work with the Exited ESP License Holder owner after a non-compete period of One Year.
- ESP License Holder Exits by upgrading to a Micro Franchisee or an Independent Franchisee of CMPTL. Clients who are willing to be shifted can be Shifted to the new Independent Franchisee Company.
- ESP License Holder Continues to be in all or any two of the models ie. ESP / SEP and/or Micro Franchisee and/or Independent Franchisee of CMPTL. Clients who are willing to be shifted to the Independent Franchisee can be Shifted to the new Independent Franchisee Company.


